#### **Context – Taranis Energy for Africa:**

Taranis Energy for Africa is part of Taranis Investment, the Perenco's investment arm and is a fund dedicated to power generation across Africa. It focuses on renewable energy (both on-grid and off-grid) as well as on conventional technologies. The investment philosophy is characterized by a diversity of investment models (through investment funds, direct minority investments, JVs...) and strong partnerships, with the aim to drive value creation and execution excellence in our portfolio.

### Roles and responsibilities:

The Investment Manager will play a key role in the development of the EfA fund, helping us achieve our growth plan across the Energy sector in Africa.

- The Investment Manager is expected to be able to lead dedicated workstreams in M&A transactions including:
  - Sourcing of investment opportunities in Energy in Africa
  - Parts of the deal execution process including Due diligence on prospective investments and prepare/present investment opportunities to Investment Committee
  - Parts of disposal processes including valuation, process letters, due diligence management, legal documentation, board and governance materials, communication, negotiations, preparation for signing and closing
- The Investment Manager is also expected to support the active ownership agenda for one or more Portfolio Companies including:
  - Take active role in the operational development of portfolio companies through supporting Full Potential Plan development and performance management
  - Board observer position in BoDs where relevant
- Other responsibilities:
  - Guide and mentor junior resources across relevant topics
  - Ad-hoc support across the Investment Team as required
  - Develop and manage the ongoing relationships with external investors and partners (e.g., investment banks, consultancies)
